

THE CORPORATION OF THE MUNICIPALITY OF RED LAKE

By-Law No. 14-2025

BEING A BY-LAW TO APPOINT A MUNICIPAL BY-LAW ENFORCEMENT OFFICER, PROVINCIAL OFFENCES OFFICER & PROPERTY STANDARDS OFFICER FOR THE MUNICIPALITY OF RED LAKE

WHEREAS pursuant to Section 15(1) of the Police Services Act, R.S.O. 1990, c.P.15, a municipal council may appoint persons to enforce the by-laws of the municipality; and

WHEREAS pursuant to Section 15(2) of the Police Services Act, R.S.O. 1990, c.P.15, municipal law enforcement officers are peace officers for the purpose of enforcing municipal by-laws; and

WHEREAS pursuant to Section 1(3) of the Provincial Offences Act a minister of the Crown may designate in writing any person or class of persons as a provincial offences officer for the purposes of all or any class of offences; and

WHEREAS on March 19, 1980, then Solicitor General, R. Roy McMurtry, designated all employees of municipalities whose duties include the enforcement of municipal by-laws as Provincial Offences Officers for the purposes of all by-law offences; and

WHEREAS pursuant to Section 15(1) of the Provincial Offences Act R.S.O. 1990, c.P.33 a provincial offences officer who believes from his or her personal knowledge that one or more persons have committed a parking infraction may issue a certificate of parking infraction certifying that a parking infraction has been committed and a parking infraction notice indicating the set fine for the infraction; and

WHEREAS pursuant to Section 15.1(3) of the Building Code Act. S.O. 1992, c.23, as amended, the council of a municipality may pass a by-law to do the following things if an official plan that includes provisions relating to property conditions is in effect in the municipality or if the council for prescribing standards for the maintenance and occupancy of property within the municipality; and

WHEREAS the Council of The Corporation of the Municipality of Red Lake has passed a Property Standards By-Law which authorizes the appointment of a Property Standards Officer for such purposes; and

WHEREAS the Council of The Corporation of the Municipality of Red Lake deems it necessary to appoint a Municipal By-Law Enforcement Officer, Provincial Offences Officer and Property Standards Officer to enforce the By-Laws of the Municipality;

NOW THEREFORE the Council of The Corporation of the Municipality of Red Lake hereby **ENACTS AS FOLLOWS**:

- 1. **THAT** Olivia Benson is hereby appointed as a Municipal By-Law Enforcement Officer for the Municipality of Red Lake.
- 2. **THAT** Olivia Benson is hereby appointed as the Provincial Offences Officer for the Municipality of Red Lake.
- 3. **THAT** Olivia Benson is hereby appointed as the Property Standards Officer for the Municipality of Red Lake.

4. THAT Olivia Benson shall enforce the By-Laws of the Municipality.
 5. THAT By-Law No. 23-2022 is hereby repealed.
 6. THAT this By-Law shall come into force and take effect on March 24th, 2025.
